Presentation	10 x 2 ml pre-filled syringes
Active ingredient	ISCOM vaccine containing Equine Influenza A/Equine/1 Newmarket '77, Equine Influenza A/Equine/2 Borlange '91, Equine Influenza A/Equine/2 Kentucky '98
Description	A vaccine for the active immunisation of horses of 5 months of age or older against Equine Influenza of H7N7 and H3N8 types (European or American strains, including Florida sublineage Clade 1 and Clade 2 isolates) to reduce clinical signs and virus excretion after infection, with duration of immunity of at least 15 months. It elicits both a cell mediated and a humoral immune response

Presentation	10 x 2 ml pre-filled syringes
Active ingredient	ISCOM vaccine containing Equine Influenza A/Equine/1 Newmarket '77, Equine Influenza A/Equine/2 Borlange '91, Equine Influenza A/Equine/2 Kentucky '98 and immunopurified tetanus toxoid
Description	A vaccine for the active immunisation of horses aged 5 months of age or older against Equine Influenza of H7N7 and H3N8 types (European or American strains, including Florida sublineage Clade 1 and Clade 2 isolates) to reduce the clinical signs and virus excretion after infection, and against tetanus to prevent mortality. Duration of immunity for the influenza is at least 15 months and for the tetanus, 36 months. It elicits both a cell mediated and humoral immune response

Presentation	10 x 2 ml pre-filled syringes
Active ingredient	Immunopurified tetanus toxoid (≥ 30 IU/ml)
Description	A vaccine for the active immunisation of horses 5 months of age or older against tetanus, with duration of immunity of at least 36 months
Dosage form	Intramuscular injection

EQUIP® Artervac

Presentation	1 ml dose pre-filled syringe
Active ingredient	Inactivated Equine Arteritis Virus (EAV)
Description	A vaccine for the active immunisation of horses and ponies against equine arteritis to reduce clinical signs and shedding of virus in nasal secretions after infection
Dosage form	Intramuscular injection
Legal category	POM-V

EQUIP® EHV1,4

Presentation	10 x 1.5 ml dose vials
Active ingredient	Inactivated EHV-1 and EHV-4
Description	A vaccine for the active immunisation of horses to reduce clinical signs due to infection with Equine Herpesvirus 1 and 4 and to reduce abortion caused by EHV-1 infection
Dosage form	Intramuscular injection
Legal category	POM-V

EQUIP® Rotavirus

Presentation	10 x 1 ml dose pre-filled syringes
Active ingredient	Inactivated Equine Rotavirus
Description	A vaccine for use in pregnant mares in order to provide passive transfer of antibodies to foals and to reduce the risk of diarrhoea caused by Equine Rotavirus G3 P12 serotypes
Dosage form	Intramuscular injection
Legal category	POM-V

EQUIP® WNV

Presentation	2 x 1 ml in pre-filled syringes
Active ingredient	Inactivated West Nile Virus
Description	A vaccine for the active immunisation of horses of 6 months of age or older against West Nile Virus (WNV) disease by reducing the number of viraemic horses after infection with WNV lineage 1 or 2 strains and to reduce duration and severity of clinical signs against WNV of lineage 2 strains
Dosage form	Intramuscular injection
Legal category	POM-V

Zylexis®

Presentation	5 x 2 ml of lyophilisate and 5 x vials of solvent
Active ingredient	Inactivated Parapoxvirus ovis
Description	An immunomodulator for horses that acts by stimulation of non-specific immune mechanisms. It is of potential clinical value in the reduction of clinical signs of equine respiratory disease associated with stress/crowding. Can be used in horses from 10 months of age
Dosage form	Intramuscular injection
Legal category	POM-V

SEDATION & ANAESTHESIA



Equimidine®

Presentation	15 ml plastic bottle
Active ingredient	Detomidine hydrochloride 10 mg/ml
Description	A sedative with analgesic properties indicated for use either alone or in combination with butorphanol to facilitate the handling of horses for clinical examinations, minor surgical procedures and other manipulations. Can also be used with ketamine for short duration general anaesthesia appropriate for short surgical procedures such as castration
Dosage form	Slow intravenous injection
Legal category	POM-V

Ketavet®

Presentation	10 ml or 50 ml glass vials
Active ingredient	Ketamine 100mg/ml
Description	An injectable anaesthetic agent indicated to induce short-acting anaesthesia in the horse in combination with an alpha-2 agonist. The product is also licensed for use in dogs and cats - see SPC for details
Dosage form	Horses: Intravenous injection only

IsoFlo®

Presentation	Amber coloured glass bottle (Type III) containing 100 ml or 250 ml isoflurane
Active ingredient	Each ml contains 100% Isoflurane
Description	A volatile anaesthetic agent for the generation of gaseous anaesthesia in horses, dogs, cats, ornamental birds, reptiles, rats, mice, hamsters, chinchillas, gerbils, guinea pigs and ferrets
Dosage form	Inhalation vapour, liquid
Legal category	POM-VPS

Torbugesic®

Presentation	10 and 50 ml amber glass vials
Active ingredient	Butorphanol 10 mg/ml
Description	An analgesic for the relief of moderate to severe pain in the horse and a sedative when given after the administration of detomidine or romifidine. The product is also licensed for use in dogs and cats - see SPC for details
Dosage form	Horses: Intravenous injection

ANTI-INFLAMMATORIES AND WOUND CARE



Depo-Medrone™ V 40 mg/ml Suspension for Injection

Presentation	5 ml bottle
Active ingredient	Methylprednisolone
Description	An injectable, long acting corticosteroid for the treatment and management of musculo-skeletal conditions in horses. Also indicated for the treatment of, or as part of a therapeutic regime for, inflammatory and allergic conditions in dogs and cats
Dosage form	Horses: Intrasyovial, intratendinous or intramuscular injection depending on intended use. For local administration, strict asepsis is required

Duphacort® Q

Presentation	50 ml bottle
Active ingredient	Dexamethasone
Description	A synthetic corticosteroid with a potent anti-inflammatory action which can be used for emergency treatment of shock and circulatory collapse and inflammatory conditions such as arthritis and dermatitis. The product is also licensed in cattle, pigs, dogs and cats and may be used whenever a parenteral corticosteroid preparation giving a medium duration of activity is indicated
Dosage form	Horses: Intravenous or intramuscular injection. The product may also be given by intra-articular injection. Normal aseptic technique should be observed

Dermisol™ Cream

Presentation	30 g or 100 g tube
Active ingredient	Propylene glycol, malic acid, salicylic acid, benzoic acid
Description	A topical cream for use in the care and management of traumatic injury, surgical wounds and infected wounds. Aids healing by cleansing wounds of necrotic debris
Dosage form	A cream for topical use
Legal category	POM-VPS

PARASITE CONTROL



Deosect® 5% Spray

Presentation	250 ml or 1 litre bottle
Active ingredient	Cypermethrin
Description	A topical solution to control flies and lice on horses. Can be used during pregnancy and lactation
Dosage form	Topical application. Must be diluted and mixed with water before use

Equest®

Presentation	1 x 14.8 g dial-a-dose syringe containing sufficient gel to treat one horse up to 700 kg bodyweight by oral administration
Active ingredient	Moxidectin
Description	A wormer for the single dose treatment and control of important internal parasites including encysted inhibited EL3 and developing intramucosal L4 larval stages of small redworms, as well as other roundworm species and bots in horses and ponies. Can be used in pregnant and lactating mares, and in foals over 4 months of age
Dosage form	Oral gel
Legal category	POM-VPS

Equest® Pramox

Presentation	1 x 14.4 g dial-a-dose syringe containing sufficient gel to treat one horse up to 700 kg bodyweight by oral administration
Active ingredient	Moxidectin and praziquantel
Description	A wormer for the single dose treatment and control of important internal parasites including encysted inhibited EL3 and developing intramucosal L4 larval stages of small redworms, as well as other roundworm species, bots and tapeworms in horses and ponies. Can be used in pregnant and lactating mares and in foals over 6.5 months of age
Dosage form	Oral gel

Excenel™ 50mg/ml Sterile Powder

Presentation	Glass vial containing 1 g or 4 g of product for aqueous reconstitution
Active ingredient	Each bottle contains ceftiofur (as sodium ceftiofur) 1 g or 4 g
Description	For the treatment of horses with bacterial respiratory disease associated with <i>Streptococcus</i> spp. (including <i>Streptococcus zooepidemicus</i>), <i>Staphylococcus</i> spp. and/or <i>Pasteurella</i> spp. Excenel is also indicated for specific infections sensitive to ceftiofur in cattle and pigs
Dosage form	Sterile white to beige freeze-dried amorphous powder for aqueous reconstitution and intramuscular injection

Orbenin™ Ophthalmic Ointment

Presentation	3g tubes. Boxes contain 12 tubes
Active ingredient	Cloxacillin (as cloxacillin benzathine) 0.5g/tube
Description	For the treatment of ocular infections in cattle, sheep, horses, dogs and cats where susceptible organisms, such as <i>Staphylococcus aureus</i> (including beta-lactamase producing strains), <i>Moraxella bovis</i> and <i>Branhamella ovis</i> , are suspected or anticipated as pathogens. A particular indication is treatment of New Forest Disease in cattle

Description	In-clinic blood glucose monitoring system calibrated for cats, dogs and horses

Presentation	500ml polypropylene bottles
Active ingredient	N/A
Description	A clear yellow solution for injection consisting of a combination of B-complex vitamins, electrolytes, amino acids and dextrose for use as supportive maintenance therapy in conditions of fluid loss
Dosage form	By slow intravenous injection only
Legal category	POM-V

Lutalyse 5mg/ml solution for injection

Presentation	Multi-dose 10ml or 30ml glass vials. Supplied in a carton containing 5 x 10 ml vials or a 30 ml vial
Active ingredient	Each ml contains 5 mg dinoprost (as the tromethamine salt)
Description	Lutalyse is indicated for its luteolytic and/or oxytocic effects in cattle, horses and pigs
Dosage form	Intramuscular injection
